- IELTS test results taken within last 24 months with overall band not less than 6.0
- Photocopy of the most recent diploma or leaving certificate, and 2009/2010 mark sheets

- Copy of all receipts for payment provided by the Canadian educational institution (pre-payment of first term is recommended)
- Copy of Educational Loan from *Indian Chartered Bank* equivalent to at least 80% of tuition +living + travel expenses for one academic year (normally, first year's tuition ,unless already paid, plus \$8000). See annex on the back of this form for the list of acceptable banks.
